Dear Applicant:

Thank you for your interest in the Annual Tonya Dorsey and New Vision Scholarship. This five-hundred dollar (\$500.00) scholarship has been established to provide scholarships to children, grades 4 through 11, who are pursuing admission to or continuance in an accredited institute of performing arts, and who have demonstrated a desire to pursue formal training.

Scholarship applications are accepted annually between February 1st and March 31st. The deadline to submit an application is March 31st; applications postmarked after March 31st are automatically ineligible and will be discarded. Completed applications can also be scanned and emailed to <u>TonyaDorseyAndNewVision@comcast.net</u> between February 1st and March 31st. The selection criteria are based on the completion of the application, essays, an interview, and audition.

Finalists will be notified in April, and an interview/audition will be scheduled within two weeks of notification. Parent/Guardian must be present for the interview/audition, after which, a final decision will be made.

Awardees will be presented with a Certificate of Award at the Annual Tonya Dorsey and New Vision Scholarship Awards Ceremony and Concert in June. Finalists will receive a Certificate of Participation.

Section I (Personal Information): Please complete all information by writing your name, address, date of birth, telephone number(s), Parent/Guardian name and telephone number, the name and address of your school, and current grade.

<u>Section II</u> (Academic and Personal Activities): "Recognition & Activities" – Please list any activities you are currently involved in or have received recognition for in the past. "Honors and Awards" – Tell us about any honors or awards you have received. "Offices & Positions of Leadership" – Tell us if you have held any office or position of leadership. (For example: Student Council) "School Activities" – Tell us any school activities you are (or have been) involved in, like choir, band, safety, etc. "Volunteer Experience" – Tell us if you volunteer at school, church, or in your community, etc.

Section III (Essays): The essays must be typed and meet the following word count minimum: Grades 4 to 6, 300 words and Grades 7 to 11, 500 words. The candidate must answer the first question and parent/guardian must answer the next question, as indicated.

Section IV (Recommendation Form): Write your name at the top of the "Recommendation Form", sign the form, and give it to the person you want to write a recommendation for you. Tell the person who is recommending you to complete the form and return it to you. **At least one completed** "Recommendation Form" must be submitted with your application. If you know of more than one person willing to recommend you, feel free to make copies of the form.

<u>Section V</u> (Disclosure and Signatures): Applicant and Parent/Guardian must Sign and Date the application.
